**SUBJECT: PARK & RECREATION COMMISSION APPOINTMENTS; ARTS  
AND RAIL COMMITTEE APPOINTMENTS**

Historically, the Town of Atherton has held a special meeting in April to interview applicants for various openings on Town Committees and Commissions. Due to competing priorities Council was not able to set a date for the interviews before term expirations which take place on April 30, 2011. Staff recommends that Council meet in a special meeting to appoint applicants to the Committees where there are more vacancies than applicants. Automatic appointment of members to the Arts Committee, Park & Recreation Commission and Rail Committee will allow these Committees to continue to meet at their regularly scheduled meeting times without interruption.
