RE: TRAFFIC REPORT – NOVEMBER 2013

The following is a summary of the activities that have occurred during the month, as well as a summary of the collision, citation and DUI statistics for the Police Department.

### **TRAFFIC COMPLAINTS**

The Atherton Police Department received one (1) traffic complaint during the month of November. The complaint was as follows:

- 1) Sandy Balling, 510-714-2091, reported vehicles picking up students from in front of Encinal School, parking in front of the “No Stopping” signs.

Results: 1 Parking Citation and 3 Warning Citations issued

### **MONTHLY DUI REPORT**

Two (2) arrests were made for Driving Under the Influence during the month of November. One (1) of these arrests was the result of a traffic collision.

### **TRUCK ENFORCEMENT DATA**

No truck stop details were performed during the month of November.

### **TRAFFIC OFFICER SCHEDULE**

For the month of November, Traffic Officer Marks was assigned to a patrol shift.

### **TRAFFIC COLLISION DATA**

During the month of November, a total of thirteen (13) traffic collisions occurred in the Town of Atherton. Five (5) collisions involved injuries. Four (4) collisions were hit-and-runs. Two (2) collisions were caused by drivers who were driving under the influence.

- 2) The intersection of James Avenue and Magnolia Drive
- 3) Middlefield Road, 15' north of James Avenue
- 4) The intersection of Middlefield Road and Linden Avenue (Injury)
- 5) The intersection of Middlefield Road and Fair Oaks Lane
- 6) The intersection of El Camino Real and Watkins Avenue (Injury)
- 7) The intersection of El Camino Real and Alejandra Avenue (Injury)
- 8) Valparaiso Avenue, 66' east of Emilie Avenue
- 9) Middlefield Road, 446' north of Ravenswood Avenue (DUI)
- 10) Alameda De Las Pulgas, 92' north of Atherton Avenue (DUI, Injury)
- 11) The property of 97 Fairview Avenue (Hit and Run)
- 12) Alameda De Las Pulgas and Polhemus Avenue (Injury, Hit and Run)
- 13) Nora Way, 20' north of Adam Way (Hit and Run)
