RE: TRAFFIC REPORT – DECEMBER 2013

The following is a summary of the activities that have occurred during the month, as well as a summary of the collision, citation and DUI statistics for the Police Department.

### **TRAFFIC COMPLAINTS**

No traffic complaints were received by the Atherton Police Department during the month of December.

### **MONTHLY DUI REPORT**

Three (3) arrests were made for Driving Under the Influence during the month of December. None of these arrests were the result of traffic collisions.

### **TRUCK ENFORCEMENT DATA**

No truck stop details were performed during the month of December.

### **TRAFFIC OFFICER SCHEDULE**

Traffic Officer Marks was assigned to a patrol shift during the month of December.

### **TRAFFIC COLLISION DATA**

During the month of December, a total of eleven (11) traffic collisions occurred in the Town of Atherton. Two (2) collisions involved injuries. Three (3) collisions were hit-and-runs. No collisions were caused by drivers who were driving under the influence.

- 2) Marsh Road, 134' west of Fair Oaks Avenue (Injury)
- 3) Middlefield Road, 320' north of Ravenswood Avenue (Injury)
- 4) El Camino Real, 90' north of Atherton Avenue
- 5) El Camino Real, 35' north of Selby Lane
- 6) Elena Avenue, 5' north of Valparaiso Avenue
- 7) The intersection of El Camino Real and Watkins Avenue
- 8) Heather Drive, 20' south of Irving Avenue
- 9) Tuscaloosa Avenue, 750' west of Austin Avenue (Hit and Run)
- 10) The intersection of Atherton Avenue and Selby Lane
- 11) El Camino Real, 15' north of Atherton Avenue (Hit and Run)
