

# Special Event Permit

- The Special Event Permit request is limited to temporary lights for a limited duration due to the COVID-19 pandemic.
- The School is required to comply with any County and State COVID-19 regulations for the activities that will occur on the field.
- All other Town regulations remain in effect, including compliance with the Town's noise ordinance.



# Public Notice & Community Outreach

- The School sent a letter to neighbors informing them of the proposed project.
- The Town mailed notice of this public hearing to all property owners within 500' of the site on November 20, 2020 and published the notice in the Almanac on November 20, 2020.

# Formal Motion

I move that the City Council approve the Special Event Permit to allow temporary lights at Sacred Heart Schools for athletic practice and co-curricular activities from January 4, 2021 through March 12, 2021 until 7:00pm on weekdays at Palatella and Dollinger Fields.
